Minutes – January 27, 2010 (approved as corrected)

The meeting of the Wilmington Neighborhood Council (WNC) was called to order by Chair Cecilia Moreno at 6:09 PM at the Wilmington Senior Center, 1371 Eubank Ave., Wilmington.

It was moved/seconded (Babbitt/Carballo) that Donna Ethington and Nelson Williams be the WNC's reps to the CRA Wilmington Plan Amendment Steering Committee.

Approved (19-0-0)

b. It is moved/seconded (Executive Board/Kern) to send a letter of support for the Harbor Subdivision to Randy Lamm, Project Manager, Los Angeles County Metropolitan Transportation Authority (Metro).

This letter was presented to the Governing Board for review at the December meeting

The letter was read aloud to those present by the Board Secretary **Approved (19-0-0)**

c. It was moved/seconded (Executive Board/Babbitt) that we support the proposed expansion project of Potential Industries.

Potential Industries made a presentation to the Board at our October, 2009 meeting

Some Board members took a tour of the facility after the October meeting

City has asked for WNC's input

Why does the old warehouse (Bekins on McFarland) have to be removed (Hernandez)

It does not meet the needs of Potential Industries in current location/condition

Approved (18-1-0)

d. Funding Request – Sharefest – Chad Mayer

2009 – conducted successful community-wide clean-up

75 middle and high school students attended Summer Youth Development Academy at CSUDH

Mayor Villaraigosa asked Sharefest to continue this effort with Avalon High Principal Awtry – Principal for 5 years

Avalon is a polished jewel of the 5 continuation schools within LAUSD

This is students' 2nd chance – provides opportunities to develop vision

Student – Valerie Pacheco

Feels the effort provides students with focus

Each creates their own mission statement

Last year only 13 participated, feels entire student body should participate

Because of program, she feels she passed her CASI

Anwar Sharif, Program Director

Comes from a theater background

Believes in personal enhancement and life plan

Will be bringing in multiple partners to help with effort

CSUDH, Tutoring, Health program, Creative writing, etc.

Program

120 students will cost \$78,000 to operate

40% already raised through corporate sponsors – Tesoro, Warren E&P

If not fully funded, will drop some components

Begins on February 9

Questions/Answers

Sullivan - Health Component – Need information on STD's, etc.

Kern – perhaps Community Health Foundation can help

Dahlgren – Does WNC have enough funds – Yes

Perez – Is there sustainability? Yes with recognition – hope to expand to other continuation schools.

Ask that WNC support Academy

Now will be a year-round program, last year only 11-weeks

Very rewarding, she keeps in touch with many of last year's graduates

It was moved/seconded (Dahlgren/Hernandez) that the WNC allocate \$10,000 to support the Youth Development Academy. **Approved (19-0-0)**

CD15 Rep. – Celina Luna indicated some Harbor area NC's wanted date change

Chair and Caraballo (ByLaws Chair) summarized the process for arriving on this

voting date and indicated other NC's lost vote by not attending previous City

Clerk meetings. Announcements indicated they would forfeit rights.

WNC specifically chose dates because it coincided with public elections

Moved (Dahlgren/Caraballo) that the WNC inform CD15 that they wish to keep the June 6 date for their election. **Approved – (19-0-0)**

Can a non-Governing Board member be chair of a WNC Committee?

Caraballo, ByLaws Chair

Only elected rep. of WNC can serve as chair of a committee

Per the By-Laws, only the Chair can speak on WNC's behalf

Pointed out that in Article 5, Section J, stakeholders are encouraged to participate and can vote after attending three consecutive meetings.

Governing Board Chair has historically appointed Committee Chairs

Caraballo explained that by-laws should be amended to specifically define who can chair Governing Board committees
