Schuyler Heim Bridge is seismically unsafe – proceeding as rapidly as possible

Environmental document completed in 2009

Bridge at highest point is 52' above mean tide

All information available on ACTA website – www.acta.gov

Board answered questions

Extension of this project to PCH is in litigation

Process: Build new bridge just East of the existing bridge, Complete half of the bridge to allow for traffic, then knock down existing bridge and build the remaining half of the structure.

Expect staging area to be on Pier A. Will not be on Henry Ford.

All existing on/off ramps will remain the same

This project will not provide pedestrian access – continuation of existing situation.

Mr. Samaro gave an overview of all work to be done

Ms. Walsh indicated the project ad been awarded to:

- 1. This is an 18-month project and must be completed by March, 2012 in order to receive reimbursement through the federal stimulus funds.
- 2. Phase 1 already in effect reduce traffic to one lane in each direction
- 3. Phases 2/3 reduce traffic to East bound only. (DWP involved)

Detour all traffic around site

This plan submitted to DOT for waiver approval

Broad Avenue between Anaheim and Harry Bridges

Board answered questions

This is one of three (3) projects related to TraPac improvements

The street surface will be asphalt with a grid underlay

Life expectancy of new surface – 20 years

"C" Street resurfacing no included in this project

A new water main will be trenched in "C" Street

Talking about repaving after this effort

No repaying of Broad Avenue planned after project waiver completion

Project does not have a PLA because of federal rules; however, company did sign contract with a local union. Harry Bridges Buffer does have a hiring contract

When project is complete will have two striped lanes in each direction with left-hand turn pockets. There is enough room for three (3) lanes when the need arises.

Board appreciates and are looking forward to the improvements

If train is at a standstill across an intersection for more than 10 minutes call

Pacific Harbor Lines – 877-250-4745

BNSF - 800 - go to website

RR's distribute product throughout the United States from LA Basin, the 2<sup>nd</sup> largest port complex in the world.

Responses to Board questions

Federal law requires horns to be blown at every public crossing Pattern – 3 short/1 long

RR's are meeting with CD-15 and WNC's Transportation Cmte.

Both Pacific Harbor Lines and BNSF are currently hiring

Encourage Wilmington residents to visit their respective web sites Undergrounding of track is done by joint effort between RR and gov't.

Responses to Public Comment

If operators are using horns to personal communication, please provide RR's with date, time and location so the issue can be investigated.

There is a different federal requirement for horns with a train speed under 15mph.

BNSF has signed two MOU's with State regarding emission reductions. Currently in the process of signing a third.

No carryover indicated at this time. Therefore, budget for next year – only \$45,000 Explained variance from last year's budget

Response to Board's questions/comments

Fiesta Corazon del Puerto will not be held in 2011

There is no set-aside for educational institutions

Motion (Kern/Ethington) to adopt budget as presented with the following changes - \$1000 for Fiesta del Corazon moved to Other in Community Outreach section and error on telephone (\$1200) be moved to Miscellaneous in Office Expenses section.

(Passed 13-0-0)

 b. International cargo Equipment (ICE) variance to permit continued use of a legal nonconforming container storage facility. City Zoning Administration - ZA 2009-4046(ZV)
Mr. Paulsson, asking for WNC's support of the variance from 30' wall requirement along Eubank and boundary with Wilmington Cemetery.

Zoning Administrator agrees this would be an unsightly situation for the community Instead will plant trees and add landscaping

ICE begun 30 years ago at present location

Tries to be good neighbor and good corporate citizen – allocates \$70,000/year to community Banning High School this year received \$40,000 for new band uniforms and next year has asked for\$10,000 for a incentive program beginning 9/2010.

ICE does try to minimize effect on community

City, with CD-15 help removed truck traffic from Eubank

Containers only 4 high and 60' back from street (only required 37')

Limit working hours, rarely work on weekends

Work force – 60; 60% of which are Wilmington residents

Response to Board questions/comments

ICE could consider donations to local parks because of budgetary difficulties

ICE would consider cleaning the West-side of Eubank Avenue

Yes, ICE does minimize noise from RR yard on Banning High area

Response to Public questions/comments

ICE will not be removing existing fence

ICE is working with Cemetery District Board on beautification of common boundary Fencing along Eubank is currently wrought iron, not chain link

Motion (Dahlgren/Osterhoudt) – WNC supports the issuance of a zoning variance to ICE (Passed 14-0-1)

- c. Metro 30-10 Imitative Overview Ethington, Chair, WNC Transportation Committee
  - 1) Voters approved Measure R, a 30-year ½-Cent Sales Tax to build approximately forty (40) transit projects
  - 2) Measure R was not a bond measure.
  - 3) Metro's 30/10 initiative would accelerate 12 transit projects through federal loans and bond sales to be repaid with the ½-Cent Sales Tax, and by borrowing from the Measure R highway funds.
  - 4) Will put people to work sooner, but could potentially reduce funding for other projects and put Metro in debt.
  - 5) Accelerated projects have no direct benefit to the Harbor Area.
  - 6) Metro is proceeding with the 30/10 initiative without any outreach or input from Neighborhood Councils.
