The only trucks permitted to use this route are those accessing the ICE facility. The Police are issuing citations to commercial trucks that are not permitted to use Eubank.

They are also conducting truck inspections and issuing citations for equipment violations, some of which are hauling ICE's containers. Because a high volume of unauthorized trucks continue to use Eubank the Council office is considering posting a sign on Eubank at PCH that would prohibit commercial trucks from turning north or south on PCH. If posted, ICE trucks would only be able to access the facility from Lomita.)
